Distinguishing Features: The second shortest covered bridge in Bucks County, the Loux bridge has several distinctive features differing it from the typical Bucks County Covered bridge. Instead of a triangular portal opening, the Loux bridge has a oval shaped portal. The inside portal walls are also absent, as are the triangular abutment caps.
