Schlicher's bridge is located on L.R. 39058 and is owned and maintained by the state highway department. This is the most recent of the remaining covered bridges in Lehigh County. It has vertical plank siding, a gable roof and stone abutments which have been enclosed in cement. A small square window is located in each of the side walls. Its portal has horizontal planking.
